LEATHERMAN PRO PURCHASE PROGRAM ELIGIBILITY REQUIREMENTS/QUALIFICATIONS:

Listed below are the categories of industry professionals Leatherman supports in its Pro Purchase Program. We offer this program as an incentive to use our products and pass your experiences with Leatherman on to the public. While we are always happy to help you get the tool that will be best for your application, we ask that you abide by the rules governing Leatherman's Pro Purchase Program.

Purchases made for anyone other than approved users will result in immediate dismissal. By completing the application, you acknowledge and agree to adhere to the responsibilities outlined in our terms and conditions. Pro accounts expire 180 days after activation or when the spending limit has been reached within that time period, whichever occurs first. You may reapply after the expiration date by submitting a new application with updated credentials.

Please read our Terms & Conditions carefully before filling out your online application. Please fill out your application completely so there are no delays in processing your approval. We review and process the applications in the order received, so please allow up to 7 days for this process to complete. If it has been longer than 7 days, please contact prosales@leatherman.com.

TERMS AND CONDITIONS

We are pleased to offer discounted Leatherman products to you as an incentive to use our products and pass your experience with Leatherman on to the public. In return for the privilege of using this program, we ask that the following requirements are met:

- ◆ You must upload the required documentation for whichever category you are applying.
- ◆ Purchases are intended for personal use only; no ordering for friends or relatives.
- ◆ Do not mention your Leatherman Pro Purchase status in any store that carries Leatherman products.
- ◆ Pro account holders may not share their account with family or friends. If clients or friends ask you about Leatherman, please refer them to our website at www.leatherman.com or to the stores that carry our product in your area.
- ◆ Shipments will only be made within the USA and Canada.
- ◆ **No orders will be shipped to PO boxes. APO for military only are fine as long as residents are of the USA or Canada.**
- ◆ **All sales are final.** Please order carefully as we cannot accept returns/exchanges unless the product is defective. Our 25-year warranty for tools applies to all Pro Purchases.
- ◆ Purchases must be made with a Visa, MasterCard, or AMEX only. We do not accept cash, money orders or checks.
- ◆ The pro site and our regular website share banners. Offers of free items, ie: engraving, shipping, gift cards, do not apply to purchases made under the pro program.
- ◆ Because our pro accounts are meant for individual use, we **do not exempt taxes** on purchases made with a government card.
- ◆ Pro Purchase privileges expire 180 days after activation or when the spending limit has been reached within that time period.
- ◆ **US Residents:** Your pro account spending privileges are valid at www.leatherman.com/pro for a total of \$345. Purchases may be made in one transaction or in several transactions until either the spending or time limit is reached.
- ◆ **Canadian Residents:** Your pro account spending privileges are valid at www.leatherman.ca for a total of \$345 USD. Purchases may be made in one transaction or in several transactions until either the spending or time limit is reached.
- ◆ Prices are subject to change without notice.
- ◆ Please allow 5-10 days for order processing. This does not include transit time.
- ◆ Leatherman reserves the right to change the terms and conditions governing this program at any time at our discretion.
- ◆ This business agreement gives Leatherman the right to terminate your account at any time.

CATEGORIES ELIGIBLE FOR THE LEATHERMAN PRO PURCHASE PROGRAM AND THE DOCUMENTATION REQUIRED AS PROOF OF ELIGIBILITY

All applicants must supply the following documentation noted in their "Pro" category via the online submission format. At least one of the marked documents from the applicable category must be submitted and should show current active status or employment. All sensitive information, such as SSN, should be blacked out for security purposes.

Please note: While we appreciate the photographs submitted by our customers, applications submitted with 'action shots' and/or 'selfies' do not qualify as proof of eligibility and will be summarily rejected if no other acceptable documentation from the list below is submitted.

For best results when applying, here are some suggestions:

- ✓ Use a desktop or laptop. Applications submitted on smart phones or tablets are not always received.
- ✓ Use Google Chrome as your browser.
- ✓ Use a home system versus a work system. Work systems often have security measures in place that may prevent the transmission of your application.

◆ **Retail Store Employee**

Currently work for a Leatherman retailer that sells products in the USA.

- ◇ Current pay stub (within 30 days of application date) with sensitive information blocked out

◆ **One of these Categories of Industry Professionals**

Employees of companies in the outdoor industry that offer reciprocal pro purchase privileges; Exhibitor at tradeshows such as OIA, SIA, SHOT, STAFDA, Interbike, ASR, DEMA or Surf Expo; Representatives of clients within the outdoor industry (at least 50% of your clients must be outdoor); Industrial Distributor Sales Representatives; Retail web site employees are not eligible.

- ◇ Verifiable participation at shows
- ◇ Information or link for Leatherman employees to participate in reciprocal pro purchase privileges
- ◇ Current pay stub (within 30 days of application date) with sensitive information blocked out

◆ **Military/LE/Fire/EMS**

Must be **active** duty military or LE; Firefighters may be volunteer or full-time

- ◇ Professional certification or copy of professional license
- ◇ National registry card
- ◇ Copy of Official Government ID (if allowed)
- ◇ Current pay stub (within 30 days of application date) with sensitive information blocked out

◆ **Boy Scouts or Girl Scouts of America**

Includes Scouts and Venture Team members

- ◇ Troop number & Council name in web address field **AND** a picture of your ID card or active ID membership, located on the Scouting website.

◆ **Ski Patrollers, Avalanche Controllers, Forest Service**

- ◇ Professional certification or copy of professional license
- ◇ National registry card
- ◇ Current pay stub (within 30 days of application date) with sensitive information blocked out

◆ **Backcountry Ski, Climbing, Mountaineering Guides**

- ◇ Guide license
- ◇ National registry card

◆ **Fly Fishing, Hunting, River, Kayak Guides**

- ◇ Guide license
- ◇ National registry card

◆ **Instructors: Ski, Snowboard, SCUBA**

- ◇ Professional certification or copy of professional license
- ◇ Coaching certificate
- ◇ Current pay stub (within 30 days of application date) with sensitive information blocked out

◆ **Outdoor Education Employee**

Outdoor education usually refers to organized learning that takes place in the outdoors. Outdoor education programs sometimes include journey wilderness-based experiences in which students participate in a variety of adventurous challenges and outdoor activities such as hiking, climbing, canoeing, ropes courses, etc.

◆ **Peace Corp (apply under Outdoor Education)**

◇ Copy of medical and dental clearance letter or copy of current pay stub (within 30 days of application date)

◆ **Adventure & Travel Companies**

Adventure & Travel companies provide an experience involving exploration or travel with a certain degree of risk, and which may require special skills and physical exertion.

◇ Current pay stub (within 30 days of application date) with sensitive information blocked out

◆ **Photographers & Media**

◇ Copy of recent publication where work was featured (within a year of application)

◆ **Adaptive Sports Professionals**

Disabled sports, also known as adaptive sports or parasports, are sports played by persons with a disability, including physical and intellectual disabilities.
